Michigan is hoping to present the following resolution to AMDA at that meeting:

#### AMDA - THE SOCIETY FOR POST-ACUTE AND LONG-TERM CARE MEDICINE RESOLUTION #3

**SUBJECT:** Real-time bidirectional communications between venues of care

**INTRODUCED BY:** Michigan Medical Directors Association

WHEREAS accurate real-time information regarding a patient is critical during transfers of care between acute care hospitals and skilled nursing facilities,

AND WHEREAS, medical documentation has moved to electronic health records and is now a required documentation modality through the Centers for Medicare and Medicaid Services,

AND WHEREAS, skilled nursing facilities and primary providers practicing in the long-term care setting often do not have access to the same electronic health records systems used by acute care facilities/primary care physicians/specialty physicians within the same geographic domain, and vice versa. Most EHR programs used in SNFs do not interface with the electronic health record systems used by their local hospital systems and primary care networks,

AND WHEREAS, due to this non-compatibility lack of interface between of EHR systems, hardcopy records are commonly used in transfer of care between the care providing entities. Hardcopy information transfer is time consuming, runs a risk of transcription errors, and is more prone to privacy violation than information shared via EHRs. Hardcopy transfer creates an inherent risk of information loss before the receiving provider reviews the information.

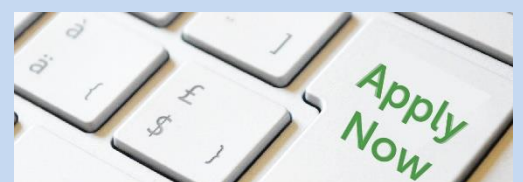

Software, which lies on top of a facility's EMR, pulling and analyzing data throughout the day. Key features of Real Time:

- It is compatible with PCC and Matrix
- It predicts the risk of rehospitalization based on changes in condition noted by alerts, keywords in progress and nursing notes, recency of admission, underlying diagnoses, and vital signs outside of normal ranges
- Generates QM reports based on CMS criteria and Infection Control reports with charts and graphs

**An overview of Real Time software is included as an attachment in the newsletter email.**

**Superior Health is offering 300 SNF's an opportunity to participate in the collaborative with Real Time at no cost to the facility through October 2024.** To date, 184 facilities are participating. Considerations include:

- The facility needs to be enrolled with Superior Health
- Facilities will need to sign a contract to allow access to their EMR
- Real Time builds all of the connections and interfaces
- Real Time supports the SNFs by providing training opportunities when the facility goes live, in addition to hosting educational opportunities throughout each month

## Nursing Home Naloxone Guide and Toolkit

The Centers for Medicare & Medicaid Services (CMS) identified a need to improve guidance related to meeting the unique health needs of residents with mental health diagnoses and substance use disorders. CMS clarified that when facilities care for residents with these conditions, policies and practices must not conflict with resident rights or other requirements of participation. CMS further clarified that facility staff should have knowledge of signs and symptoms of possible substance use, and are prepared to address emergencies (e.g., an overdose) by increasing monitoring, administering naloxone, initiating cardiopulmonary resuscitation (CPR) as appropriate and contacting emergency medical services. This naloxone nursing home toolkit is intended to provide easy-to-adopt policies and procedures for nursing homes that need to implement or improve their emergency response to opioid overdose, which includes naloxone administration.

## CDC UPDATES ON INFLUENZA, RSV, and COVID-19 VACCINATIONS *contribution from WSU – CEID*

### CDC Recommendations for Testing and Management of co-circulating Respiratory Diseases

The Centers for Disease Control and Prevention (CDC) released [guidance](#) for testing nursing home residents with respiratory virus symptoms when COVID-19 and flu are co-circulating.

- Residents showing symptoms should be isolated, with staff using appropriate personal protective equipment (PPE) in the care of residents and tested for both respiratory viruses
- Residents testing positive for either virus should remain in isolation and only be cohorted with other residents who have tested positive for the same virus
- Residents who have only tested positive for one virus should not be cohorted with residents who have only tested positive for the other virus

## Antiviral treatment for COVID-19 is lifesaving

### Current evidence suggests:

- Patients with COVID-19 rebound
  - experience return of mild symptoms 3-7 days after initial illness or positive test
  - might or might not have taken antiviral treatment
- No hospitalizations or deaths due to rebound were reported in the reviewed studies

Antivirals should be prescribed to all eligible COVID-19 patients

### [SARS-CoV-2 Rebound With and Without Use of COVID-19 Oral Antivirals](#)

COVID-19 rebound was observed in people who did and did not receive antiviral treatment, and rebound symptoms typically appeared as a mild illness 3-7 days after the initial illness ended.

### [Evaluation of SARS-CoV-2 RNA Rebound After Nirmatrelvir/Ritonavir Treatment in Randomized, Double-Blind, Placebo-Controlled Trials](#)

Viral rebound rates were similar between patients with and without antiviral treatment.

### [Coverage with Influenza, Respiratory Syncytial Virus, and Updated COVID-19 Vaccines Among Nursing Home Residents](#)

As of December 10, 2023, 33% of nursing home residents were up to date with COVID-19 vaccination. Among residents at nursing homes that elected to report, 72% had received a flu shot and 10% had received an RSV vaccination.

### [Influenza, Updated COVID-19, and Respiratory Syncytial Virus Vaccination Coverage Among Adults](#)

As of December 9, 2023, 42% and 18% of adults aged 18 years and older reported receiving the 2023-2024 flu vaccine and the updated (2023-2024) COVID-19 vaccine, respectively. RSV vaccination coverage among adults aged 60 years and older was 17%.
